

Degree course regulations for doctoral studies at the Hochschule für bildende Künste Hamburg

17.12.2020

Working in accordance with 108 section 1 Hamburgischen Hochschulgesetz (HmbHG), the President's Office of the HFBK Hamburg moved on 17.12.2020 to approve the "degree course regulations for doctoral studies" at the Hochschule für bildende Künste Hamburg" adopted by the University Senate on 17.12.2020 on the basis of § 85 section 1 HmbHG.

Preamble

These degree course regulations supplement the provisions of the doctoral examination regulations of the Hochschule für bildende Künste Hamburg from 19.11.2020.

§ 1 Purpose of the degree

- (1) A doctoral programme seeks to equip candidates to complete a doctoral procedure and obtain the qualification Dr. phil. in art.
- (2) The award of a doctoral degree demonstrates possession of the ability to perform scientific or artistic-scientific work.

§ 2 Period of study

- (1) The standard period of study in a doctoral programme amounts to ten semesters.
- (2) Doctoral candidates can submit a well-founded application to the doctoral committee for an extension to the period of study by the end of the eighth semester at the latest. In accordance with § 3, the application must include proof of six semester weekly hours of academic achievement. The doctoral committee will take the decision on the basis of a simple majority. If the application is not approved, § 7 section 1 sentences 2 and 3 PromO apply.

§ 3 The structure of the degree course

Doctoral candidates are required to submit proof that they have attended doctoral colloquia, research seminars or workshops / conferences worth a total of eight semester weekly hours within the ten semesters of the standard period of study.

The relevant proofs are to be signed by the first supervisor and are to be submitted to the HFBK Examination Office upon the opening a doctoral procedure in accordance with § 9 section 2 number 1 PromO.

§ 4 Teaching forms

A range of teaching forms can be employed, but will especially focus on:

- a. Doctoral colloquia
- b. Research seminars
- c. Workshops / conferences

§ 5 Performance monitoring

Students are required to compose research reports and give presentations in classes. Doctoral candidates are required to record their attendance at both research seminars and the doctoral colloquia through signatures. They are also required to demonstrate participation in workshops and conferences.

§ 6 Credit transfer of academic achievement outside the HFBK

The doctoral committee (after consultation with the supervisors) can rule to accept specialist academic achievement from other universities or academies as equivalent to certain requirements of the doctoral degree.

§ 7 Commencement

- (1) These degree course regulations take force the day after their approval by the President's Office. They apply to doctoral candidates who start their doctoral studies in summer semester 2021.
- (2) They come into force in summer semester 2021 and also apply to all doctoral candidates who started their doctoral degree before this point.
